TOPICS: **Tour - Optional Tour of Athens Wastewater Treatment Plans - Project Manager Scott Stearns, P.E., BCEE,** will give a tour of the recently upgraded WWTP

which was the largest Capital Improvement Project ever undertaken in the City of Athens. The \$18 million project included a new ultraviolet disinfection system that replaced a chlorine gas system, resulting in a major safety improvement for both plant operators and the public. In addition, the project added new primary and secondary clarifiers, new influent screening and pumping, and a bioreactor odor control system. A new septic receiving station was also included in the project, which allows local haulers to dispose of it rather than shipping it to adjacent municipalities.

City of Athens Capital Improvement Plan Update - City of Athens Engineer Andy Stone will give an update on the City's Capital Improvement Plan and an overview of the WWTP Upgrade project. Andy is the city engineer and director of Public Works. He holds a Bachelor's Degree in Civil Engineering from The Ohio State University, a Master's Degree in Civil Engineering from Ohio University, and is a registered professional engineer in the State of Ohio. He also serves as an engineer officer in the Ohio Army National Guard. He has worked for the city since 2003.

Ohio University & The Ohio State University Student Chapters - The student chapters will give presentations of updates on their projects, teams, and organizational activities.

PAJK 2016 ADVOCATE OF THE YEAR

Jim Pajk, P.E., M.ASCE, Central Ohio Section Member, Ohio Council Treasurer/Secretary, ASCE Federal Advocacy Captain, and Franklin County Deputy Engineer, was honored with – and surprised by – the 2016 *Outstanding Civil*

Engineering Advocate of the Year Award.

"I'm so used to everyone pronouncing my name incorrectly, so I was caught off guard," laughed Pajk. "It is a nice honor, but it is due to



some help from members back in Central Ohio." Jim received the award from ASCE President Mark Woodson at the ASCE Legislative Fly-In. The award recognizes Jim's successes in engaging and building relationships with Ohio members of Congress to gain support of ASCE's Priority Issues.

The 2016 Fly-In was the sixth for Pajk. He had five meetings on Capitol Hill, engaging the staffs of Senators Brown and Portman, as well as Representatives Tiberi, Beatty, and Renacci, in addition to many meetings with the Congress people and staff at their Ohio-based offices.

"It's important to engage all levels of government, be it state legislation or federal, letting people know who we are and the resources we can become for them," Pajk said. "I think civil engineers have a tendency maybe to stay back a little too much on the sidelines. Civil engineering affects all our lives. I think it's important for representatives to know that. It becomes a very easy thing to advocate."

2016 LEGISLATIVE FLY-IN

On Wednesday, March 16 over 200 ASCE members representing 49 states descended on Capitol Hill in Washington, DC for the annual Legislative Fly-In. Three members from Ohio attended, including 2 from the Central Ohio Section. As if to send a message, attendees learned during Tuesday evening issues briefings that the Washington Metro was closing for 29 hours to make emergency inspections, meaning the Metro would be closed on the day of the Congressional visits. This was a timely talking point for infrastructure improvements since many Congressional staffers were impacted by the lack of public transportation, highlighting the importance of infrastructure. Central Ohio Section members met with the staffs of Senators Brown and Portman, as well as Representatives Tiberi, Beatty, and Renacci. The focal point of the legislative visits centered on three main points:

- Federal Aviation Administration bill reauthorization - The push is to reauthorize a bill in 2016 to allow certainty for aviation programs which have been operating under temporary extensions since 2015. ASCE has pushed to increase or eliminate the cap on Passenger Facility Charges (PFC) to allow airports flexibility in funding their individual needs, and to require

Quality Based Selection for these engineering services. Similarly, funding in the Airport Improvement Program (AIP) should be increased.

- Water Resources Development Act (WRDA) passage - ASCE is encouraging Congress to pass a new WRDA bill in 2016 to keep the bills on a two-year cycle, and to fund it to levels included in the 2014 bill. This provides certainty for local agencies. To minimize the likely hood of situations like the Buckeye Lake Dam, Congress should authorize a Dam Rehabilitation Program to fund repair, rehabilitation, and removal of non-federal dams, of which there are 87,000 in the United States with an average age of 52 years.
- Increased investment in water infrastructure - Well documented cases in Flint, MI and Sebring, OH highlight the need for funding in water infrastructure. ASCE encourages an increased investment in State Revolving Funds for both Drinking Water and Clean Water programs, which are the primary funding mechanisms in this arena. There is also a need to fully fund the Water Infrastructure Financing Program (WIFIA) and to create a Water Infrastructure Investment Trust Fund.

Purpose and Background

Design of several masonry elements straddles the border between architectural and structural disciplines. Among these are masonry walls, steel lintels, and brick veneer. In a typical project, the architects include these components in their construction documents, drawings, and specifications. By contrast, structural engineers address these elements in various ways, with some fully designing and detailing them, and others only referring to typical notes and details. In some cases, the engineers' input is limited to a review of project specifications. Occasionally, load bearing masonry walls and shear walls are not even shown in the structural drawings, because the engineers use computer software that designs and draws structural steel but not masonry.

Since architects and engineers deal with different design aspects of these masonry elements, their design details tend to emphasize certain information and omit other. Quite often the same condition is shown slightly differently in the

architectural and structural drawings. Some contractors exploit the apparent inconsistencies and submit RFIs and change orders, claiming conflicting or insufficient information. This webinar helps explain how such claims, and even litigation, could be avoided.

Purpose and Background

Drilled shafts are a common foundation selection for all types of structures. When the soil is relatively poor quality and the structure loads are relatively large, the shafts are often drilled through the poor soils into underlying rock mass is present. These shafts could be founded or seated on the rock mass surface, or they could be drilled into the rock mass to form a rock socket. This webinar concentrates on the geotechnical analysis for drilled shafts that derive their axial and lateral resistance from rock sockets. The webinar is based upon Load and Resistance Factor Design (LRFD) methodology as per the specifications of the American Association of State Highway and Transportation Officials (AASHTO). It discusses load transfer models for axial and lateral behavior of rock sockets. It also discusses selection of appropriate rock parameters and methods of axial and lateral load analysis.

- Side resistance
- Tip (base) resistance
- Lateral resistance
- Strain compatibility between soil overburden and rock socket

- Definition of rock strength – intact versus rock mass


